As METGÜN Energy Investments Inc. ("Company"), we prioritize the protection of fundamental rights and freedoms, ensuring the confidentiality of private life, safeguarding information security, and upholding ethical values. Article 11 of the Personal Data Protection Law (PDPL) No. 6698, titled "Rights of the Data Subject," grants data subjects the right to make certain requests regarding the processing of their personal data. As the Data Controller, our Company has prepared this information request and application form to facilitate the exercise of these rights by data subjects and to fulfill its obligation to inform, as stipulated in Article 10 of the PDPL.

Pursuant to Article 11 of the PDPL, you may exercise the following rights by submitting an application to the Company and filling out the attached form:

- a) You may inquire whether your personal data has been processed,
- b) If your personal data has been processed, you may request information regarding this,
- c) You may learn the purpose of processing your personal data and whether it is used in accordance with that purpose,
- d) You may inquire about third parties, either domestic or abroad, to whom your personal data has been transferred,
- e) If your personal data has been processed incompletely or inaccurately, you may request its correction,
- f) Within the conditions specified in Article 7 of the PDPL, you may request the deletion or destruction of your personal data,
- g) Pursuant to sections (e) and (f), you may request that the actions taken be communicated to third parties to whom your personal data has been transferred,
- h) You may object to any outcome that is to your detriment as a result of the exclusive analysis of your processed data through automated systems, and
- i) If you suffer damage due to the unlawful processing of your personal data in violation of the PDPL, you may request compensation for your loss.

Pursuant to Article 13 of the PDPL, data subjects must submit their requests to our Company in writing or through other methods determined by the Personal Data Protection Board ("Board"). In this context, applications to our Company can be submitted free of charge by choosing one of the following three methods after completing and printing this form.

Our responses will be delivered to you in written or electronic form as per Article 13 of the PDPL.
